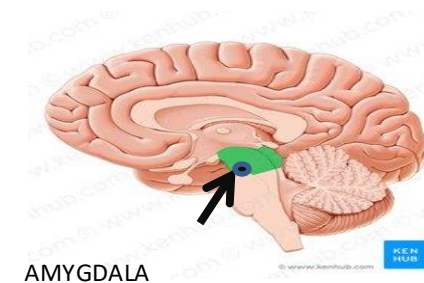
Demonstrate the ability to identify

To increase awareness of the service within criminal justice settings.

**The benefits of the accreditation will result in more referrals from the offender supervisors/probation as can be evidenced as part of the prisoners' overall sentence plan.**

**To provide an accredited intervention either one to one or group delivery to prisoners, staff, family, or friends who are affected directly or indirectly by problematic gambling.**

**For the prison to appoint a prisoner to be a representative/peer mentor of Breakeven Within the establishment and explain the services offered to all new incoming prisoners on induction as well as those already in custody.**
